We have launched a historical campaign, **RAISE THE CURE**, an initiative to secure federal and private funding for pancreatic cancer research. As part of this initiative, we have presented the *National Plan to Advance Pancreatic Cancer Research* to the federal government asking for \$170 million in funds dedicated to

pancreatic cancer research. The Pancreatic Cancer Action Network has also committed to raising \$25 million in private donations over the next three years. To make this initiative a success, we need your help.
